Consent to Use Information for Bank Product Determination

Tax Preparer will use the Personal Information by initiating an electronic analysis and calculation of the Personal Information via Software Developer's tax preparation software. The purpose of the Use is to determine which bank products(s) (for example, Federal and / or State Refund products disbursed via check, direct deposit or card) may be available to Taxpayer.

Consent to Use Information for FeeCollect PS Application

Tax Preparer will use the Personal Information by initiating an electronic analysis and calculation of the Personal Information via Software Developer's tax preparation software. **"Purpose"** :The purpose of the Use is to determine whether Taxpayer is eligible for the FeeCollectPS service, which allows the Taxpayer to pay the tax preparation fees via a direct deduction from their 2015 tax refund or personal bank account.

Consent to Disclose Information for FeeCollect PS Application

The purpose of the Disclosures is for Software Developer to transmit Taxpayer's FeeCollect PS application to Bank for processing and administration of the FeeCollect PS service which allows the Taxpayer to pay the tax preparation fees via a direct deduction from their 2015 tax refund or personal bank account.

Consent to Disclose Information for Bank Product Application

The purpose of the Disclosures is for Software Developer to transmit Taxpayer's bank product application to Bank for consideration and potentially to provide Taxpayer with a bank product (for example, Federal and / or State Refund products disbursed via check, direct deposit or card).

Consent to Use Information for Protection Plus Eligibility Determination

Tax Preparer will use the Personal Information by initiating an electronic analysis and calculation of the Personal Information via Software Developer's tax preparation software. For your convenience, we have entered into an arrangement with Tax Protection Plus ("PROVIDER") to provide tax preparers with the opportunity to enroll taxpayers in Protection Plus Audit Assistance through Protection Plus.

Consent to Disclose Information for Protection Plus Application

You have indicated that you are interested in enrolling in Protection Plus Audit Assistance through Tax Protection Plus ("PROVDER"). In order to have your enrollment processed by PROVIDER, we must disclose your 2015 tax return information to PROVIDER.
